FIELD(SubDoc:Header) ADJUSTMENT OF FINES ORDER

This matter having come before the court and the court being advised in the premises, the court FINDS:

1. The above-named defendant was convicted, with fees assessed, was sentenced to pay a fine and signed an Agreement to Pay the Fine (And Court Costs) pursuant to §31-12-3 NMSA 1978.
2. The defendant defaulted on the Agreement and the default is not willful.

IT IS THEREFORE ORDERED:

1. Payment due dates for fines/fees shall be extended as indicated below:

2. The fine shall be reduced by \$KEYBOARD(Enter Amount Fine Reduced By), remaining fine payable as indicated above.
